## **Membership for Armajun Health Service Aboriginal Corporation**

Armajun Aboriginal Health Service has had to change its legal status. Armajun was registered as an Incorporated Association under the Incorporated Associations Act (2009) with the NSW Department of Fair Trading. New conditions for funding from the Australian Government was introduced in 2015 and Armajun was required to become registered under the Office of the Registrar of Indigenous Corporations (ORIC) under the Corporations (Aboriginal and Torres Strait Islander) Act 2006 (the CATSI Act) in order to continue to receive funding.

Armajun Health Service Aboriginal Corporation became registered on the 20<sup>th</sup> August 2015 and continues to trade as Armajun Aboriginal Health Service.

### **Membership Eligibility requirements:**

A member must be:

- at least 18 years old
- An Aboriginal or Torres Strait Islander person normally and permanently resident in the Armajun service area for 12 months or more and who has confirmation of Aboriginality from a recognised incorporated Aboriginal organisation.

There is NO FEE payable to become a member.
